## Terms and Conditions

### Definitions

- “Company” refers to Wonderfully Made Interiors and its successors
- “Hirer” refers to the individual(s), company, or trust named in the attached quote/contract for furniture hire, including any person(s) acting on behalf of or with the authority of the Hirer.
- “Furniture” refers to the items supplied on hire by Wonderfully Made Interiors to the Hirer, including any necessary accessories.

### Initial Hire Period

- The Hirer will pay the hire fee in full prior to delivery. This includes securing truck bookings, scheduling stylist/s, and making furniture selections. Delayed payment may result in project delays.
- If the property is occupied during staging, a bond of \$500 may be required (e.g. tenants, pets).
- The minimum non-refundable hire period is five weeks, starting from the commencement date.
- A packing fee of \$250 will apply if the Hirer cancels the job more than 24 hours after it has been accepted.

## Extension of Hire Period

- To extend this agreement beyond the Initial Hire Period, the Hirer must provide one week's notice to Wonderfully Made Interiors.
- The hire period may then be renewed on a week-by-week basis, not exceeding a total of eight weeks during the high season.

## Access and Access Arrangements

The Hirer shall grant Wonderfully Made Interiors or its agents access to the property, including keys, alarm codes, and other necessary details, for inspection, delivery, and removal of staging items, especially if a representative of the Hirer cannot be present.

## Delivery, Set Up, and Collection

- Delivery and collection costs are included in the Initial Hire Fee. Unless notified otherwise at the time of delivery, the Hirer agrees that the Furniture has been delivered safely and without causing damage to the property.
- Once staging has been installed to Wonderfully Made Interiors' professional standards, additional fees may apply for any changes, additions, or removals requested by the Hirer during the staging term.
- The Hirer must inform Wonderfully Made Interiors of any personal furniture/items that need relocation (e.g., pianos, pool tables) as additional charges will apply. This includes returning these items after staging has concluded.
- Wonderfully Made Interiors will not be liable for minor damage caused by the installation of the Goods, which includes holes from nails or screws, and carpet indentations from furniture.
- Installation may be rescheduled due to inclement weather.

## Hirer Responsibility

- The Hirer agrees to keep the furniture in good condition and not to move or relocate any items without prior approval from Wonderfully Made Interiors. The Furniture is for display purposes only and cannot be used otherwise.
- The Hirer is responsible for any damage or soiling of the furniture or accessories during the staging period and will cover costs for restoration, cleaning, or replacement.
- Outdoor cushions and chair pads should only be placed outdoors for photography and open homes (if applicable).
- It is the Hirer's responsibility to inform Wonderfully Made Interiors and/or third parties of any visible wear and tear or defects that may be concealed by the furniture.

## Insurance of Goods and Furnishings

- Wonderfully Made Interiors insures the home staging furniture and accessories within your property.
- The owner/agent must ensure that the home is adequately secured, especially after open home viewings. If a burglary occurs without forced entry, the owner/agent will be responsible for Wonderfully Made Interiors insurance excess.
- The home/property owner is responsible for insuring their home and any personal furniture remaining at the property.
